

# 2026 NBS Winter Community Competition – Tasman Mako Experience Giveaway

## Terms and Conditions

By entering this competition (**Competition**), you agree to be bound by these terms and conditions. The competition is run by the Nelson Branch of Nelson Building Society (registration number 1781002), 111 Trafalgar Street, Nelson, 7010 (**NBS**).

2. The competition will commence on Tuesday 2 June 2026 and will close at 4.30pm (NZ time) on Tuesday 30 June 2026 (**Promotion Period**).
3. To be eligible to enter the competition, a participant must:
  - a. complete the entry form on the NBS website on the page: [www.nbs.co.nz/mako](http://www.nbs.co.nz/mako),
  - b. currently reside in the Nelson Tasman region,
  - c. be over the age of 18 years old,
  - d. not be a current NBS employee or an immediate family member of a current NBS employee.
4. A participant may enter once only.
5. The winner will be drawn at 12pm Wednesday 1 July 2026 at NBS' head office at 111 Trafalgar Street, Nelson. NBS' decision is final and no correspondence will be entered into.
6. NBS will notify the winner using the contact details provided, after 12pm Wednesday 1 July 2026. NBS and the winner will agree on arrangements for collection of the Prize. All participants agree that if they win, they will be required to visit the Nelson branch of NBS to collect the Prize.
7. If the winner does not respond to NBS' reasonable attempts to contact them by 12pm Friday 10 July 2026, that winner will be deemed to have forfeited their right to claim the Prize and NBS will draw an alternative winner.

By entering this competition, participants consent for NBS to use their photograph and name in conjunction with any reasonable publicity associated with the competition, in the event that they win the Prize.
